We serve clients of all abilities with physical, cognitive and emotional disabilities from all over the world in three locations in the winter in Vermont – Killington Resort and Pico Mountain in Killington; Sugarbush Resort in Warren; and Bolton Valley in Bolton. HIGHLIGHTS



Vermont Adaptive celebrated the 10th
Anniversary of the The United States Association
of Blind Athletes' (USABA) Annual Winter Ski
Festival at Pico Mountain. Athletes from across the
country with visual impairments, including veterans,
were given the opportunity to learn to ski or race
in the sports of alpine and Nordic skiing. This year
Vermont Adaptive acquired an Eko-Aims Rifle and
Biathlon Target, made possible by a Veteran's
Administration grant. The laser rifle is designed
to help train visually impaired athletes using
auditory signals to guide their aim and was used
at the USABA Winter Ski Festival this year.

Other partnerships developed as well this year as Vermont Adaptive hosted clients from Spaulding Rehabilitation, the Division for the Blind and Visually Impaired, Mt. Sinai Hospital, Healing Waters, the High Fives Foundation, the Kelly Brush Foundation, and Zeno Mountain Farms to name a few.

As part of its outreach, Vermont Adaptive continued to exhibit at Abilities Expo Boston and the Boston Ski and Snowboard Expo. Other events and partnerships included being the beneficiary for the second year of the Subaru Share the Love campaign (Vermont Adaptive was the local charity of choice for Rutland's Kinney Subaru) as well as the Vermont Sports Medicine Center 5K Run/Walk.

Nearly 600 cyclists participated in the 6th Annual Long Trail Century Ride to benefit Vermont Adaptive. Long Trail Brewery was the title sponsor for the fifth year in a row and has become an integral partnership to the organization. A large après-ride party was held at the brewery in Bridgewater Corners after the ride. All riders began and ended their rides at the brewery. Killington Resort again sponsored the ride, as did many local businesses including Phil Black (ride founder) of the Lookout Tavern.



Wermont Adaptive again participated in the national #GivingTuesday campaign, highlighting the first Tuesday in December when people are encouraged to give back and/or pay it forward to their community or favorite charity. C.O.R.E. Connections wellness programs and retreats continued this year as well, due in part to a grant from the Bowes Health Trust. In February, Vermont Adaptive, in conjunction with the High Fives Foundation, hosted 12 skiers with spinal cord injuries at the US Paralympic Alpine Ski Racing Camp at Sugarbush Resort, with Paralympic Gold Medalist Chris Devlin-Young as head coach of the camp.

A quiet kick-off of Vermont Adaptive's **new adaptive mountain bike program** began in the summer with custom hand cycles crafted in the mountains of Crested Butte, Colo. Made specifically for rocky terrain, these unique hand cycles are designed for adaptive riders to cruise down the trails smoothly.

Vermont Adaptive received a grant from the U.S. Department of Veterans Affairs, which allowed the Veterans Venture Program to grow with more retreats at Pico Mountain/Killington Resort, weekly gatherings at Bolton Valley and on the Burlington waterfront, the availability of travel and transportation, and a culmination of the winter season with a group attending the National Disabled Athletes Winter Sports Clinic with program coordinator Kelly Walsh. Volunteers, staff and board members participated in NPR's StoryCorps series. Interviews were recorded in StoryCorps' mobile unit in Burlington and will be archived in the National Library of Congress. The **Department of Labor** awarded the organization a grant to continue to cultivate the internship program, providing double the amount of funds than the previous year. To conclude, Vermont Adaptive leadership began the quiet inquiry launch of Phases II and III of the Home Sweet Home permanent homes campaign (Sugarbush Resort and a home on the Burlington Waterfront).

EQUIPMENT

It is hard to imagine ski equipment that allows those who cannot stand or walk to have the ability to experience the sport of skiing. Recently, technology has transformed adaptive ski equipment from heavy, awkward pieces of machinery into light, dynamic and user-friendly tools. Technological advances have been instrumental in enabling those with disabilities to participate in a wider range of recreational activities, however, those advances make participating in these sports cost prohibitive for many.

For example, the adaptive sailboat that is specifically designed for people with spinal cord injuries cost the program more than \$10,000. As a result, more and more of these individuals have come to rely on Vermont Adaptive to provide them with the opportunity to enjoy sports in the great and beautiful Vermont outdoors.
